Item 7. Report of Superintendent. The Superintendent informed that Delta Motors balanced Well 11 motor to stop vibration. Ardsheal pressure station malfunctioned during a planned shutdown and caused two service leaks on El Travesia. Both leaks were repaired the same day. The pressure station was also repaired after taking it out of service to repair the leaks. We repaired three service leaks and repaired a 4" main leak on Encanada. In addition, the cathodic protection system was inspected, and an additional anode installed at tank 10A. The system was found to be protecting the tank, but Accurate Corrosion recommends replacing the internal coating as soon as possible. An internal inspection was performed at the La Mirada reservoir to measure sand build up on the tank floor. Lastly, repairs were done twice on a 2-inch service at 507 Vista Del Llano.

Item 8.a. Discuss and Action - Heli Hydrant Update - East Skyline Drive. After a discussion, a letter is to be drafted by District staff and sent to the City of La Habra Heights related to specifics of the heli-hydrant. This item was continued until the next scheduled board meeting.
