Item 8. Report of Individual Directors.

Pam McVicar discussed the following items related to the ACWA/JPIA conference:

Mike is on the list of people who completed the leadership training, a total of 69 people have completed this program since 2015.

Workers compensation meeting currently includes workers compensation for inmate labor, even though they are unpaid and are considering excluding the program; only one district is using it. They looked at increasing retention, but premium reduction is not worth it. There

will be no increase this year. The use of opioids is overwhelming drug costs and they have a program to reduce overuse called first fill. They are also giving rebates to several districts for zero losses. Brain Bowcock Director of Three Valleys said they gave it to the employees.

At the executive committee meeting there is a plan to reduce reserves to \$19 million from \$43 million they cut premiums to reflect the difference. There is continual talk about Captive Insurance Company, expect to have it to a vote in the next year.

At the regular meeting there was discussion on snow pack using NASA's Airborne Snow Observatory (ASO). This improves reliability of snow forecasts. This is critical for districts in charge of managing the runoff. Lastly, there is a statewide issue forum for the California Water Plan update 2018. It proposes to impose a fee on the end users of \$8-\$12 per month per household to pay for state water infrastructure. They are looking at an unfunded subsidy program. It is supposed to be in the comment period, but the plan is not available.

Karen Baroldi discussed General Manager's evaluation form to be used next year and she participated in World Vision 6K Run La Habra for Water and thought maybe others would be interested in participating next year.

Item 9. There being no further business to come before the Board, motion was made by Director Perumean and seconded by Director McVicar that the meeting be adjourned at 8:18 p.m. Vote was as follows:
