Payments are posted on the date they are received in the District office, not the date post-marked. If payment is not received in this office by the due date, the bill is considered delinquent and a Late Charge of 7% will be added to the bill. If water service is flow restricted due to non-payment of account, the total amount of the bill, plus any additional fees and charges outstanding will be required before restoring service.
